



## FNSC Refund Policy

Effective April 2024

### Refund Policy

The club will issue a refund of fees if the Registrar receives a written request on or before one week before the program starts:

- **Youth Recreational Streams (Bunnies, Jackrabbits, Teen Ski and Marmots)**
- **Adult Recreational Streams**
- **Youth Competitive (Nordic and Biathlon)**
- **Adult Competitive (Masters)**

No refunds may be made for requests received after this date unless the Executive Director determines that, due to exceptional circumstances, a full or partial refund is warranted.

All refunds are subject to a 20% administrative fee.

### **CASL (Canadian Anti-Spam Legislation)**

#### **Giving Consent**

The Foothills Nordic Ski Club will obtain your consent to collect, use and disclose personal information per this privacy statement, except where otherwise permitted or required by law. Consent may be expressed, or it may be implied in appropriate circumstances. You may choose not to provide us with personal information. However, withholding personal information may restrict our ability to provide you with some services. It may also make it difficult for us to communicate with you.

#### **Minors**

A parent and/or guardian will be required to provide consent on behalf of a minor.

#### **Withdrawing Consent**

You may withdraw your consent to the Foothills Nordic Ski Club for collecting, using or disclosing personal information at any time, subject to legal or contractual restrictions and reasonable notice. If you withdraw your consent, the implications of that withdrawal may be that the FNSC is not able to provide or continue to provide you with the service you requested. In addition, the ability to communicate with this person may be diminished. A withdrawal of consent will not be effective concerning the recording and reporting of incidents. To withdraw consent, contact our offices and identify which personal information you no longer wish to be collected.

#### **Access to and Changing Your Personal Information**

If you want to access or verify your personal information's accuracy, please get in touch with the club's administrator. At the time your request is received, we may ask for specific information to verify your identity before the personal information can be revealed. There may be instances where the personal information may not be disclosed. These would include situations where:

- the personal information includes references to other persons,
- the information has already been destroyed due to legal requirements or because it is no longer needed,
- it cannot be disclosed for legal reasons.

Where an error or inaccuracy is noted in personal information, contact your club administrator with the correct information to make changes. If they cannot change it or will not change it, then please get in touch with the Calgary Minor Soccer Association. We will provide a copy of the corrected information upon request.
